

- 1. The promoter is Noosa Council (ABN 97 969 214 121)
- 2. To enter the Competition you must complete the official entry form and deposit it in any one of the competition entry boxes located at each of the Noosa Libraries branches i.e. Noosaville, Cooroy or Mobile or submit via email to libraryevents@noosa.qld.gov.au by 11:59PM AEST, Tuesday 13 February 2024.
